

Alfa|SIGMA approved a cash dividend of US \$0.0063 per share

- ▶ Dividend equivalent to approximately US \$35 million

(“ALFA”, “Alfa|SIGMA”) (BMV: ALFAA), announced today a cash dividend of US \$0.0063 per share to be paid as of October 14, 2025. The dividend is equivalent to approximately US \$35 million and was approved by the Board of Directors on October 1, 2025, exercising the powers delegated to it in Alfa|SIGMA’s Annual Shareholders’ Meeting held on March 25, 2025.

Including this payment, cash dividends to Alfa|SIGMA shareholders total approximately US \$119 million in 2025.
