

## Proposal to change the legal entity name and consequently amend certain articles of the corporate bylaws

ALFA, S.A.B. de C.V., informs on the proposal to change its corporate legal entity name to Sigma Foods, S.A.B. de C.V., and consequently amend certain articles of the corporate bylaws where its current corporate name is mentioned.

Proposals to amend Articles 1, 6, and 39 of the Company's bylaws to update references to its current corporate name Sigma Foods, S.A.B. de C.V. Please note that the bylaws are only available in Spanish. See text below:

**"ARTÍCULO 1.-** La Sociedad se denomina **"SIGMA FOODS" ALFA**. Esta denominación deberá ser seguida de las palabras **"SOCIEDAD ANÓNIMA BURSÁTIL DE CAPITAL VARIABLE"**, o de las iniciales **"S.A.B. de C.V."**

**"ARTÍCULO 6.-** Las personas morales que sean controladas por **Alfa Sigma Foods**, S.A.B. de C.V. no podrán adquirir, directa o indirectamente, acciones representativas del capital social de **Alfa Sigma Foods**, S.A.B. de C.V. o títulos de crédito que representen dichas acciones. ...."

**"ARTÍCULO 39.-** ... Para efectos del presente Artículo, se entiende por **"Acciones"**, las acciones representativas del capital social de **Alfa Sigma Foods**, S.A.B. de C.V., ... ."
